To Whom It May Concern:

RE: Authorization Letter for Shenzhen Intra Brands Co Ltd.

This letter is to confirm that Jaliro International Ltd. And its wholly owned subsidiary Shenzhen Intra Brands Co., Ltd.(collectively, "Licensee")is a licensee of The Goodyear Tire&Rubber Company ("Goodyear"), Akron, Ohio, USA, pursuant to the agreement dated as February 2, 2017(the "Master Agreement"). Therefore Shenzhen Intra Brands is the only official licensee in China and no other company has such rights in these territories. More specifically the companies named Tianranyuan(深圳市天然源投资有限公司), Taran, Taryan and Huabiao(华标实业(深圳)有限公司) are not authorized licensees or distributors.

As a Goodyear licensee, Shenzhen Intra Brands Co., Ltd. has been granted rights to produce, distribute, advertise and promote the following category of products bearing Goodyear trademarks:

"(i)Car and motorcycle accessories consisting of seat covers, cushions and pillows, drink holders, phone and PDA/GPS holders, AC and 12v/24v power socket converters, chargers and adaptors, 6V and 12V batteries, slip proof mats to hold objects on the dashboard, blankets, dustbins, car mats and rolls of car mats, car and bike covers, car organizers, steering wheel covers, car vacuum cleaners, car coolers and warmer boxes, air fresheners, reflective vests, ratchet tie downs, towropes, petrol funnels, radio antennas, gear locks, steering wheel locks, battery cables, battery booster packs, jump starters, air compressors, headlamps, work and flashlights, lanterns, mechanics and driving gloves, bulbs, wind shield shades, snow chains

ice scrapers, tire gauges, tire pressure monitor system(TPMS), racks, roof bars, wheel covers, cosmetic covers and decorations for vehicle components (i.e., pedals, stripes, gear shifts, petrol caps and wheel covers), high pressure washers (consumer type only), recovery tracks, digital video recorders, interior hangers, solar film, tire bags, car fuses, thermometers

and clocks, FM transmitters, mugs, impact wrenches, air purifiers, mirrors(angle enhancements), rubber door guards and roadside assistance kits(which specifically include the following items which cannot be sold separately: booster cables, towropes, warning triangles, safety vests, gloves, emergency hammers, long nose pliers, wrenches, bits, tape, cable ties, flashlights, bags and non-branded fire extinguishers), engine cleaners consisting of engine oil protectant, oil system cleaners, concentrated fuel injector cleaners, engine flush, engine coating and engine surface cleaners, and night vision driving glasses;

(ii) Car wash accessories consisting of cleaning kits, non-rubber garden hoses and multiple spray garden nozzles with rubber handles, cleaning wipes and cloths, waxing and polishing machines, brushes, waxing cloths, car wax, wind screen liquids, tire foam, car wash liquids, glass cleaning liquids, leather cleaning liquids, dash board cleaning liquids and polishing waxes;

(iii) Car jacks;

(iv) Wind shield wiper blades with standard, flat or hybrid technology and replacement blades to be sold in the replacement equipment market and wiper protectant (the items in sections (i) through (iv) shall herein after be referred to as "Automotive Products");

(v) Bicycle equipment consisting of hand tools, tire levers, GPS/computers, bike gloves, grips, saddles, bicycle bags (handlebar bags, saddle bags, baskets and rack bags), bike lights,

bike computers, locks, air compressor, pumps, saddles, bells, water bottles and water bottle holders;
